NOTIFICATION

The Lieutenant-Governor, Puducherry is pleased to make the following rules further to amend "The Puducherry Old Age Persons and Destitutes Pension (Amendment) Rules, 2014 notified in G.O. Ms. No. 3/2015-WCD(SW-IV), dated 13-3-2015 of the Women and Child Development Secretariat read with G.O. Ms. No. 42/2011-Wel(SW-IV), dated 23-12-2011 and G.O. Ms. No. 8/2013-Wel(SW-IV), dated 24-12-2013, namely:—

RULES

1. *Short title and commencement.*— (i) These rules may be called “The Puducherry Old Age Persons and Destitutes Pension (Amendment) Rules, 2015”.

(ii) They shall come into force on and from the date of their notification in the official gazette.

2. *Amendment of rule 3.*— In the Puducherry Old Age Persons and Destitutes Pension (Amendment) Rules, 2014, (hereinafter referred as the said rules) in clause (m) of rule 3, for the figure '40' the figure '21' shall be substituted.

3. *Amendment of rule 7.*— In the said rule in clause (1) of rule 7, the symbol, figure and words ‘₹ 1,100 per mensem’, the symbol, figures and words ‘₹ 1,500/2,000/3,000 per mensem fo persons with age groups 18-59, 60-79 and 80 and above respectively’ shall be substituted.

4. *Amendment of forms.*— In Form-II (Order of sanction of pension), in para 1 for the figure ‘₹ 1,100 and words in brackets (Rupees one thousand and one hundred only)’ “₹(Rupees.....only)” shall be substituted.

All beneficiaries on roll will be fixed within the span of respective age groups by calculation of their age as on 1st May, 2015, the effective date of enhancement of pension as cut-off date to ensure uniformity and this method of calculation of age shall be adhered to in subsequent years for disbursement of appropriate quantum of pension"
